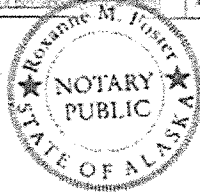

COMPLAINT

Complainant: John P. Lambert
Respondents: Interior Voters For John Coghill, and
Working Families Of Alaska
Date: January 31, 2018
RE: Violations of AS § 15.13.070(b), (c)

Introduction

Alaska Citizen John P. Lambert brings this complaint under Alaska Statutes § 15.13.380 because Respondents Interior Voters For John Coghill (“Interior Voters”) and Working Families Of Alaska (“Working Families”), both registered independent expenditure groups, accepted contributions that exceeded the statutory limits on contributions.

Alaska Statutes § 15.13.070(b) provides that individuals may not contribute more than \$500 per year to groups like Interior Voters. Alaska Statutes § 15.13.070(c) provides that groups that are not political parties may not contribute more than \$1,000 per year to groups like Interior Voters and Working Families. Despite these limits, both respondents accepted contributions from individuals and groups well in excess of these limits. Interior Voters accepted multiple contributions from individuals in excess of \$500, including at least one donation of \$2,500; and it accepted multiple contributions from groups in excess of \$1,000, including a series of contributions from a single group that totaled \$47,000. *See* Ex. A. Similarly, Working Families received at three donations from groups of \$25,000 or more each. *See* Exs. B–D.

Complainants suspect that these violations have not been enforced because of the Commission’s view that Alaska’s contribution limits to independent groups “may be unconstitutional.” *See* Commission Advisory Opinion 12-09-CD (June 6, 2012), at 7–8. But Alaska’s limitations have never been ruled unconstitutional by any court. To the contrary: in *Thompson v. Dauphinais*, 217 F. Supp. 3d 1023 (D. Alaska 2016), a federal court expressly *upheld* these statutory limits against a constitutional challenge. Alaska’s failure to enforce this law thus violates the executive’s duty to faithfully execute the laws of this State, *see* Alaska Const. art. III § 16, and it undermines the U.S. Constitution’s guarantee that each state shall have a republican form of government, *see* U.S. Const. art. IV § 4.

Facts

The following facts are taken from publicly-available reporting documents. These publicly-available documents and other publicly-available sources form the basis of the complainants’ knowledge of these violations.

A. Interior Voters. The group Interior Voters For John Coghill is registered as an Independent Expenditure Group in Alaska. Ex. A at 1. In the 2016 election cycle, it made expenditures that explicitly supported John Coghill, a 2016 candidate for Alaska State Senate, and opposed

November 1, 2016, Interior Voters reported expenditures of over \$50,000 on advertisements and media buys that explicitly supported Coghill or opposed Hopkins. Ex. A at 2-3. These expenditures were made between October 24, 2016 and October 28, 2016 – only days before the November 8, 2016 election.

These expenditures were funded by contributions that exceeded the legal limit. From October 20, 2016 to October 28, 2016, Interior Voters accepted contributions of \$52,000 to support these spending activities. These donations came in several very large chunks that greatly exceeded the statutory maximum amounts that apply to contributions from both individuals and groups.

Interior Voters accepted the following unlawful contributions:

- \$2,500 from individual Scott Hawkins;
- \$2,000 from individuals John and Victoria Hill;
- \$47,000 from an outside group called “The Accountability Project.” This is the combined total of distinct contributions in the amount of \$6,000, \$26,000, and \$15,000.

See Ex. A at 3-4.

Senator John Coghill won the election by just over 1,000 votes, and he is currently a State Senator.

B. Working Families. The group Working Families Of Alaska is also registered as an Independent Expenditure Group in Alaska. Ex. B at 1. In the 2016 election cycle, it made expenditures that explicitly supported candidates including Vince Beltrami and Adam Wool. In filings dated from September 30, 2016 to October 21, 2016, Working Families reported over \$70,000 of expenditures. See Exs. B-D.¹

These expenditures were funded by contributions that exceeded the legal limit. From September 30, 2016 to October 21, 2016, Working Families accepted contributions of \$175,000 to support these spending activities. These donations came in three large chunks, each of which exceeded the statutory maximum amounts that apply to contributions from groups:

- \$50,000 from group Laborers Local 341, on September 30, 2016;
- \$50,000 from group Laborers Local 341, on October 11, 2016; and
- \$75,0000 from group Laborers’ Political League Education Fund.

See Exs. B-D at 3-4.

Violations

Violation 1: Violation of Alaska Statutes § 15.13.070(b) by accepting an individual contribution of over \$500 (Interior Voters).

Alaska Statutes § 15.13.070(b) provides that individuals may not contribute more than \$500 per year to groups like Interior Voters. Nonetheless, Interior Voters accepted and reported a contribution of \$2,500 from Scott Hawkins, an individual. The acceptance of this contribution violates Alaska election law.

Violation 2: Violation of Alaska Statutes § 15.13.070(c) by accepting a group contribution of over \$1000 (Interior Voters and Working Families).

Alaska Statutes § 15.13.070(c) provides that groups (other than political parties) may not contribute more than \$1000 per year to groups like Interior Voters and Working Families. Nonetheless, Interior Voters accepted and reported contributions totaling at least \$47,000 from The Accountability Project, a group that is not a political party. Further, Working Families accepted and reported contributions of at least \$175,000 from two different groups, in amounts that exceeded the legal limit. The acceptance of these contributions violates Alaska election law.
